The CCIM Institute Foundation Chapter Member Challenge Official Rules

To be eligible to enter with a chance to win a prize for your CCIM Chapter, please follow these rules:

- 1. Eligibility: The 2023 CCIM Institute Foundation Chapter Member Challenge (the "Challenge") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry and members of either The CCIM Institute or a CCIM Chapter. Employees of The CCIM Institute Foundation and other companies associated with the promotion of the Challenge, and their respective parents, subsidiaries, affiliates, and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to enter the Challenge. - 2. Entry Period: The Challenge begins on October 13, 2023, at 12:00AM Central and ends on October 24, 2023, at 11:59 pm Central (the "Entry Period"). Entries submitted before or after the Entry Period will be disqualified as an eligible entry for the Challenge.

3. How to Enter:

- a. <u>Donation Entry</u>: Make a donation at: <u>https://ccimef.ejoinme.org/chapterchallenge</u> during the Entry Period. Donation minimum of \$25.
- b. <u>Alternate Means of Entry</u>: Send an email to: Foundaiton@ccim.com. The email must contain all and only the following information- Subject Line: 2023 CCIM Institute Foundation Chapter Member Challenge, CCIM ID #, your full name and contact information, and the CCIM Chapter of choice (that will receive the prize upon random drawing).

Each entrant must identify a CCIM Chapter of choice to win one of the prizes in this Challenge. Limit one (1) entry per member regardless of method of entry. Sponsor is not responsible for the lost, late, incomplete, or ineligible entries. Late entries will not be eligible.

• Second Prize: One (1) \$1,000 scholarship for The CCIM institute Chapter to award to a local member.

Prizes are non-transferable, no substitution of the prize will be permitted, except that Sponsor reserves the right, in its sole discretion, to substitute the prize with either the cash value of the prize that would have been awarded or a prize of equal or greater value in the event the prize becomes unavailable for any reason. Chances of winning depend on the number of eligible entries received for each CCIM Chapter.

Persons found tampering with or abusing any aspect of this Challenge, as solely determined by CCIM, will be disqualified. Any attempt to damage any website of CCIM, or tamper with or undermine the legitimate operation of the Challenge, is a violation of these Official Rules.
- 8. Liability Release. Entrant understand that by entering the Challenge, the winners will be selected by random drawing and entrant must identify a CCIM Chapter of choice to receive the prize(s), as set forth herein. Entrant agrees that their participation in the Challenge is on the condition that CCIM and its agents, officers, directors, representatives, and employees will have no liability whatsoever for any injuries, losses, or damages of any kind resulting from the acceptance, possession, misuse, or use of the prize or participation in the Challenge.
